9.0 Conditions of Entry Policy

9.1 Context & Aim

Patrons and visitors attending Bayside Community Netball Facility Stadium must comply with all laws, regulations, directions and policies issued by any government authority or Bayside & district Netball Association (BDNA) staff or delegate. While this facility is managed by BDNA, by authority of Bayside City Council.

For the comfort, safety and enjoyment of all patrons, staff and participants, entry to this venue is subject to the following Conditions of Entry.

9.2 Prohibited Items

The following items are not permitted in the venue.

- Bicycles, scooters, skateboards, and rollerblades/skates
- Illegal substances, including controlled, dangerous, or illicit drugs
- Incendiary devices, including flares, fireworks, and smoke bombs
- Firearms and explosives, chemical, radioactive, or biological substances
- Laser lights
- Alcohol (unless permission has been sought & granted as per 9.3)
- Animals (other than assistance dogs)
- Glass (including bottles)
- Any other item that in the opinion of management, could cause harm or public nuisance

9.3 Alcohol

BDNA's alcohol management policy is in place at the venue. In line with this policy the court area and surrounds will be designated 'alcohol free' during competition hours.

The indoor venue is not licensed and as such, the following provisions apply:

- Alcoholic beverages must not be taken into the venue
- Intoxicated persons will be refused entry/ evicted from the venue(s)
- An appropriate liquor licence must be obtained when serving alcohol at an association/team function or event and all legal requirements arising from this must be complied with. Approval for a licence application must be sought from BDNA and Bayside City Council.
- It is an offence for minors to purchase or consume alcohol, or for a person to supply alcohol to a minor.
- Breaches of these laws may result in eviction from the venue and the persons being reported to the Police (penalties apply under the Liquor Control Reform Act 1998).

9.4 Smoking

Smoking and/or vaping is not permitted inside the venue or anywhere on the grounds managed by BDNA or anywhere within the Sandringham Secondary College Grounds, including the car park and adjacent gardens.

9.5 Restrictions on Entry

BDNA reserves the right to refuse entry to any person

9.6 Ejection from Venue

A person may be ejected from the venue where that person:

- Breaches the Child Safety Standards and/or

- Breaches the Victorian Government Fair Play Code or Netball Australia Member Protection Policy or Netball Victoria Codes of Conduct and/or
- Uses foul or abusive language or makes discriminatory or threatening remarks or gestures and/or
- Is deemed by BDNA Staff to be displaying offensive, disorderly or unlawful behaviour and/or
- Enters the venue or other restricted internal area without proper authorisation; and/or
- Fails to comply with these conditions of entry or a lawful request from BDNA
- Any person/s identified by BDNA Staff to be engaged in any practice considered to be involved with transmitting information from sporting events for the purpose of gambling

No fees will be refunded if a person is ejected from the venue

9.7 Other Conditions

- Patrons & visitors are advised that the venue is fitted with CCTV electronic surveillance and patrons may be filmed in any public area of the venue
- Patrons and visitors enter the venue at their own risk and BDNA Management has no liability for any damaged, lost or stolen property nor for any other loss, damage or injury suffered by any patron, whether in contract, tort or statutory liability to the full extent permitted by law.
